**ORDER:**

Provisional recognition was granted to Classes I to VII (EM) in respect of Navaneeta School, East Kanpur(V) Chillakur (M), S.P.S.R.Nellore District for a period of 10 years ie from 2017-18 to 2026-27 vide Proc Ldis No.3634/B2/2017 dated 24-06-2017 of the District Educational Officer, SPSR Nellore District.

The Secretary and Correspondent, CHINTA VISWESWARA RAO EDUCATIONAL SOCIETY Hyderabad has applied for according Permission to open classVIII (E.M) at a stretch during the academic year 2018-19 in respect of Navaneeta School, East Kanpur(V) Chillakur (M), S.P.S.R.Nellore District.

The Inspecting Officer, ie. Deputy Educational Officer, Gudur, SPSR Nellore District has caused inspection and submitted the report in the reference 2nd cited.

After careful examination of the proposals from the Society and also the inspection report of the Inspecting Officer in the reference 2nd cited and in terms of rule 3(2) of G.O. Ms.No. 1 Education Department dated 01-01-1994, permission is hereby accorded to Open Class VIII (E.M) without aid during the academic year 2018-2019 in respect of Navaneeta School, East Kanpur(V) Chillakur (M), S.P.S.R. Nellore District subject to fulfillment of the following conditions.

1. Adequate qualified staff should be appointed as per staff pattern and they should be paid salaries prescribed by Government from time to time.
2. That the society shall abide the instructions, rules and regulations made by Government or authorized officer from time to time.
3. Library should be enriched at least with 1000 books includes reference books and provide separate accommodation.
4. Laboratory should be expended by adding more number of working models both under Physical and Biological Sciences.
5. Adequate furniture should be provided.
6. Adequate Audio visual equipment should be provided.
7. Adequate play materials should be provided.
8. Text books should be followed prescribed by the Government.
9. All Registers should be maintained.

10. The Society shall apply for Provisional Recognition within 2 months at the latest duly fulfill all the conditions.
11. The permission accorded is restricted to this year only and the permission will not confer any right on the Educational Agency to claim Provisional Recognition unless the conditions are fulfilled.
12. The permission is accorded to Navaneeta School, East Kanpur(V) Chillakur (M), S.P.S.R.Nellore District and no other Society or Body can open a school on their behalf and it is not transferable.
13. The permission is accorded to open the school in the premises and locality as specified in the application and their should not be any change in the premises or locality.
14. The Society should provide the necessary material even if it costs more then the deposit amount.
15. The Governing Body should be constituted.
16. Parent Teacher Association should be constituted
17. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
18. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
19. They are requested to fulfill all the conditions prescribed in the G.O.4th and 5th read above and its amendments issued from time to time are complied with fully.
20. The Management is requested to follow the instructions of the Fire Department scrupulously and submit a copy of renewal the Fire Certificate time to time.

Further, the managing committee of the school is requested to fulfill all the conditions to cope up with the needs of the institution at the latest before submission of application for Provisional Recognition to class VIII (E.M) without aid from the year 2018-2019 in respect of Navaneeta School, East Kanpur(V) Chillakur (M), S.P.S.R.Nellore District

After Careful examination of the references read above and the conditions prescribed in G.O.Ms.No: 1 Edn., Dt:1-1-1994 ,G.O.Ms.No.41 Edn. Dt: 11-05-2006, G.O.Ms.No. 74 Education Dt: 11-09-2006 and as per the instructions issued by the Commissioner and Director of School Education, Andhra Pradesh, Hyderabad in the reference 10th cited, the Regional Joint Director of School Education, Guntur is here by accorded for grant of Provisional Recognition for a period of 09 (Nine) Years to class VIII (EM) from the academic year 2018-2019 to 2026-2027 in respect of Navaneeta Public School, East Kanpur(V) Chillakur (M), S.P.S.R. Nellore District Without aid now and in future subject to fulfillment of the following conditions. However by the end of April every year, the Educational Agency shall file an affidavit to the effect that there is no deviation or violation of norms/rules prescribed by the Government from time to time and the management is requested to comply with the following without fail.

1. That the society shall abided the instructions, rules and regulations made by Government or authorized officer from time to time.
2. That the Educational Institution shall serve the needs of the locality more particularly.
3. That the instructions shall adopt the curriculum and syllabus prescribed from time to time.
4. The school timings, vacation and mid-term holidays shall be as prescribed by the Government from time to time.
5. That the qualified staff with in the age limits prescribed by Govt., for Govt., Employees shall be appointed as per the Staff pattern.

6. That the results of the Institutions shall be satisfactory every year.
7. That the records /accounts shall be furnished to the D.E.O every year.
8. That the list of Governing body shall be furnished to the D.E.O. every year.
9. That the pay structure/fee structure fixed by the governing body shall be got approved by the D. E.O. every year.
10. That all the conditions prescribed in G.Os and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents/DEO and competent authority at least 6 months before.
12. That the school shall be closed or permitted to closed only from the date on which summer vacation is declared.
13. That the society shall submit proposal for renewal of Extension, of Temporary recognition sufficiently in advance i.e., at least 6 months prior to the date of expiry of the renewal.
14. The Recognition now given is purely on a temporary basis and is subject to the reports of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under the A.P. Education Act, 1982 and if later found that the School has not fulfilled any prerequisites as stipulated, the Recognition now being given is liable to be withdrawn at once.
15. The Management is requested to follow the instructions of the Fire Department and renewal the Fire Certificate from time to time without fail and submit the same to this office through the Deputy Educational Officer, Gudur, and District Educational Officer, SPSR Nellore District.
- 16 The Management is requested to renew the Vehicle Fitness Certificate every year from the concerned authorities without fail and submit the same to the concerned Deputy Educational Officer.

Further, the managing committee of the school is requested to fulfill all requirements to cope up with the needs of the institution at the latest before submission of application for Extension of Temporary Recognition for the year 2027-2028.
